#### **Monthly Summary**

- Index performance shows a significant decline in market sentiments, where ASPI declined by 317.88 points, S&P SL 20 declined by 65.04 points and AWLI has gained by 40.61 points.
- Previous month turnover of LKR 42.72 Bn has significantly decreased and recorded a turnover of LKR 15.43 Bn.
- Foreign inflows were led by SPEN.N and outflow were led by JKH.N, while net foreign inflow indicated a significant inflow of LKR 0.89 Bn.
- Top gainers list was led by EXPO.N with 15.94% gain and top losers were led by CSF.N -20.00% with a thin turnover.
- Multiple crossings took place during the week where HAYL.N was the highest among them with a crossing value of LKR 682.99 Mn.
- Several dealings by directors were noted during the week.
- Monthly Tea prices movement where high grown, medium grown average tea prices indicated a significant decline in prices, whereas low growth depicts a moderate increment in price and volume.
- T bill rates have depicted a slight decline in auction prices, whereas standing deposit facility rate and standing lending facility rate remained unchanged.
- Monthly AWPR has declined by 37 basis points (0.37%) to 21.03% compared to the previous month.
- The Global Commodity market has shown a marginal decline in commodity prices compared to the previous month.
- International markets showing moderate positive market sentiments, where Nifty 50 depicts the highest increment by 4.06%.





#### **ASPI Index Chart**




#### **S&P SL 20 Index Chart**





# Net Foreign Inflow (Yearly/Monthly) Net Foreign Inflow (Yearly)




## **Net Foreign Inflow (Monthly)**

Foreign sales for the Month amounted to LKR 1.43 Bn.


Net foreign inflow for the Month was LKR 0.89 Bn and YTD net foreign inflow is LKR 1.56 Bn.








