Monthly Summary

- Index performance shows a significant decline in market sentiments, where ASPI declined by 428.04 points, S&P SL 20 declined by 196.3 points and AWLI declined by 117.19 points.
- Previous month turnover of LKR 15.43 Bn has decreased to LKR 14.00 Bn this month.
- Foreign inflows were led by JKH.N and outflows were led by HNB.N, while the net foreign outflow for the month was LKR 0.18 Bn.
- Top gainers list was led by RGEM.N with a 81.50% gain and top losers were led by BLUE.N with a 33.33% loss with thin turnovers.
- Multiple crossings took place during the week where JKH.N was the highest among them with a crossing value of LKR 648.00 Mn.
- Several dealings by directors were noted during the month.
- Tea prices indicated a significant decline over the previous month. However there was a significant increase in the volumes.
- T bill rates have declined in auction prices, whereas standing deposit facility rate and standing lending facility rate reduced to 13.00% and 14.00% respectively compared to the previous month.
- Monthly AWPR has declined significantly by 116 basis points (1.16%) to 20.29% compared to the previous month.
- The Global Commodity market has shown a decline in commodity prices compared to the previous month.
- International markets showed mixed market sentiments, where Nikkei 225 depicted the highest increment of 9.25%.





ASPI Index Chart




S&P SL 20 Index Chart




Net Foreign Inflow (Yearly/Monthly) Net Foreign Inflow (Yearly)

Foreign sales for the Month amounted to LKR 1.60 Bn.


Net foreign outflow for the Month was LKR 0.18 Bn and YTD net foreign inflow is LKR 1.38 Bn.




Top Foreign Transactions



Highest Turnover Composition







SL economy moving from recovery to stabilising phase

Sri Lanka's economy is recovering faster than predicted levels, supported by the decreasing inflation, the appreciation of the rupee, and global prices which have led to the cutting of policy rates by 250 basis points (bps), Central Bank of Sri Lanka (CBSL) Governor Dr. Nandalal Weerasinghe said. Speaking to reporters yesterday (1) at the Monetary Policy Revive press conference, he said that the Sri Lankan economy is returning to normal "much earlier than predicted", as the economy is moving from the stabilisation phase to the recovery phase. He said that in order to further support the recovery, the Central Bank has decided to cut policy rates by 250 bps, bringing the Standing Deposit Facility Rate (SDFR) and the Standing Lending Facility Rate (SLFR) to 13% and 14% respectively.

Loans from offshore banking units fell to 551 billion rupees in March 2023 from 617 billion rupees a month earlier, central bank data showed. Loans from domestic banking units also fell to 6,601.8 billion rupees from 6,643.4 billion rupees."
