### SL targets 5 Mn tourists by 2029

Sri Lanka Tourism Promotion Bureau (SLTPB) Chairman has laid out a five-year recovery plan targetting five million tourist arrivals to the country by 2029. He praised Sri Lanka's "amazing comeback" following a challenging period grappling with the after-effects of Covid-19 and the country's worst economic crisis since its independence in 1948. Visitor numbers to Sri Lanka dropped to 700,000 last year – a substantial decrease compared to the country's best-ever year in 2018, when 2.3 million travellers visited the island country in South Asia. But the Chairman remained "confident" Sri Lanka would reach its target of 1.5 million for 2023, claiming the destination had already nearly surpassed 1.2 million visitors. (Source: themorning.lk)
