


Weekly Summary


- The Index performance showed an improvement in market sentiments, where the ASPI gained by 82.41 points, S&P SL 20 gained by 50.43 points, and the AWLI gained 5.54 points.
- However, the previous week's turnover of LKR 3447.63 Mn has Significantly increased to LKR 7,945.67 Mn this week.
- Top gainers were led by RGEM.N with a 41.45% gain, and the top losers were led by ASPH.N with a loss of 33.33% with thin turnovers.
- Some crossings took place during the week, where SLTL.N was the highest amongst them, with a LKR 1.26 Bn turnover.
- Few dealings by directors were noted during the week.
- T bill auction results showed a decline in rates compared to the previous week. The 91-days declined by 0.29%, 182-days declined by 0.12% and the 364-days declined by 0.03%
- Weekly AWPLR declined by 0.57% compared to the previous week, whereas the standing deposit facility rate and standing lending facility rate remained constant at 10.00% and 11.00% respectively.
- A general and slight appreciation of the LKR was noted in the movement of FX rates.
- The Global Commodity market has shown a general decrease in the commodity prices except for the price of Gas Propane Aramco.
- International markets showed mixed market sentiments this week.



ASPI Index Chart




S&P SL 20 Index Chart





Almas Whitelist index (AWLI)




Net Foreign Inflow (Yearly)
